### About The Show

Satan's Callback is a contemporary puppet theater piece that offers a glimpse into the human experience of unemployment. This carnivalesque and timely performance tells the story of 28-year-old Noora Kalliala, who gets caught in the clutches of a hellish bureaucracy while desperately striving for a place in Heaven. Satan's sauna sessions in Hell and the efficiency of capital-serving Heaven frame the unemployed person's struggle in purgatory, a state of eternal waiting and barely getting by. The performance aims to remind us that societal conditions can be improved while respecting individuals' lives and honoring their freedom of choice.

#### About Art

The government's investment of 1.3 billion euros generates an output of 14 billion euros.

The current government is implementing historically severe economic policies at an exceptionally fast pace to balance the Finnish economy. These harsh measures disproportionately impact the unemployed and the poor. Additionally, the Ministry of Finance has proposed a 4.3 million euro cut in cultural and arts funding for 2025. While this may seem like a small reduction within the overall arts budget, it follows an 8.2 million euro cut already made in 2024. Moreover, the financial outlook for municipalities that also fund the arts is bleak, and further cuts are likely in the coming years. Are politicians overlooking the long-term consequences of these budget cuts? Even if funding is increased in the future, it may not revive cultural activities that have already been lost. Starting over from scratch could be too challenging.

Art is a form of work that cannot thrive without adequate funding. As resources dwindle, so do the quality, accessibility, and diversity of artistic expression.

Satan's Callback reminds us of the human impact of decisions driven by numbers and bureaucracy. It's essential to improve social conditions while also valuing individual lives and respecting freedom of choice.
